PRIVACY POLICY





DHMS Civils Limited, is committed to maintaining the privacy of personal information that you provide to us when using the DHMS Civils web site. PRIVACY POLICY PROMISE

- We will attempt to keep customer files complete, up-to-date, and accurate. We will tell our customers how and where to
 conveniently access their information (except when we're prohibited by law) and how to notify us about errors which we
 will promptly correct.

INFORMATION WE COLLECT

GENERAL:

When you register, and at other times, we may collect personally identifiable information from you that may include your name, address, telephone number, e-mail address, and facts about your computer. We do not, however, knowingly collect personal information from children under the age of thirteen. In addition, if a user is under 18, unless consent is obtained from your parent/quardian, you are not allowed to provide us with personal information.

WEB SITE USAGE INFORMATION: We automatically collect IP addresses and Web site usage information from you when you visit our Web site. This information helps us evaluate how our visitors and customers use and navigate our Web site on an aggregate basis, including the number and frequency of visitors and customers to each Web page, and the length of their visits.

 your personal information when we, in good faith, believe that the law requires us to do so.

COOHIES

We employ cookie technology to help visitors and customers move faster through our site. When you sign on to our Web site or take advantage of several key features, we may pass cookies to your computer. A cookie is a string of information that is sent by a Web site and stored on your hard drive or temporarily in your computer's memory.

SECURITY

The personally identifiable information we collect about you is stored in limited access servers. We will maintain safeguards to protect the security of these servers and your personally identifiable information.
